The steepness of the birth curve relative to the death curve may be interpreted as new establishments mostly starting out very small with just a few employees and expanding later, while larger establishments may still be liable to dissolution.

Gender comparison

The following graphs provide kernel density estimates for the distribution of gender proportions at the establishment level. These estimates are derived as follows: Gender proportions are calculated per establishment for full-time, part-time, and total employment. This is done by taking the number of male (full-time/part-time) employees and dividing it by the number of (full-time/part-time) male and female employees. E.g., if the proportion for part-time employees is 1, then all part-time employees at the establishment are male. Hence, we can see which proportions occur most and whether there are multiple peaks.
